ORDER:

In the reference 2nd read above, Government have issued orders, relaxing the upper age limit by 3 years for a period of one year from the date of issue of G.O., to the various categories of the posts to be notified for the purpose of direct recruitment by the Telangana State Level Police Recruitment Board.

In the reference 4th read above, the Director General of Police, Telangana State, Hyd., has submitted revised proposals stating that a joint representation was received from certain unemployees, requesting to fix the cutoff date as on 01-07-2015 instead of 01-07-2016 as done for the recruitment of Police Constables vide notification issued on 31-12-2015, so as to enable further more number of candidates to apply for the post of Sub-Inspectors.

3. The Director General of Police, Telangana State, Hyderabad, has requested the Government to raise the upper age limit by (4) years instead of (3) years for the notifications issued in this year 2016, to the various categories of posts and subsequent notifications to be issued till 20.12.2016 for the purpose of direct recruitment by the Telangana State Level Police Recruitment Board.

4. In view of the above circumstances stated by the Director General of Police, Telangana State, Hyderabad, and after careful examination of the matter, Government hereby decided to raise the upper age limit by (4) years instead of (3) years for the notifications already issued in this year 2016 to the various categories of the posts and also subsequent notifications to be issued till 20-12-2016 for the purpose of direct recruitment by Telangana State Level Police Recruitment Board., in continuation of the G.O. 2nd read above.

5. This order issues with the concurrence of the State Election Commission, Telangana State, Hyderabad, vide their Lr.No.562/TSEC-L/ 2016, dt. 01.03.2016.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Telangana hereby make the following adhoc rule, namely:-

ADHOC RULE

Notwithstanding anything contained in the Special or adhoc rules for the recruitment in Police department, Special Protection Force, Fire Services and Prisons department, the maximum age limit prescribed in the said rules for appointment by direct recruitment shall be raised by (4) years instead of (3) years, in continuation of the G.O.Ms.No.86, Home (Legal) Dept., dated 21-12-2015, for the notifications already issued in 2016 to the various categories of the posts and also subsequent notifications to be issued till 20-12-2016 for the purpose of direct recruitment by Telangana State Level Police Recruitment Board.
