**SUPPLEMENTARY NOTIFICATION**

**Amendment to the notification Rc. No. 01/Rect./Admn.1/2016 dated 06-02-2016**

The Government vide G.O. Ms. No. 26, Home (Legal) Dept., dated 02-03-2016 have raised the maximum age limit prescribed for appointment by direct recruitment by (4) years instead of (3) years in continuation of the G.O.Ms.No. 86, Home (Legal) Dept., dtd. 21-12-2015 for the notifications already issued in 2016 for various categories of the posts and also subsequent notifications to be issued till 20-12-2016 for the purpose of direct recruitment by Telangana State Level Police Recruitment Board.

**In view of the above, the following amendment is given for the notification issued in Rc. No. 01/Rect./Admn.1/2016 dated 06-02-2016 for the posts of SCT SIs (Civil/AR/SAR/TSSP), SIs in SPF and Station Fire Officers.**

**A M E N D M E N T**

**In the said notification, against para 13 (B) (a) (i) & (ii), the following is substituted:**

**Age Limit: (General)**

- a) i) **For the post code nos. 11 to 14 & 16** : Must have attained the age of 21 years and must not have attained the age of 25 years as on 1<sup>st</sup> July, 2016. However, the Government of Telangana vide G.O.Ms.No.26, Home (Legal) Department, dated 02-03-2016 has raised the maximum age limit by (4) years. This relaxation is in addition to the upper age limit as mentioned above.
- ii) **For the post code no. 17** : Must have attained the age of 18 years and must not have attained the age of 30 years as on 1<sup>st</sup> July, 2016. However, the Government of Telangana vide G.O.Ms.No.26, Home (Legal) Department, dated 02-03-2016 has raised the maximum age limit by (4) years. This relaxation is in addition to the upper age limit as mentioned above.

**In the said notification, against para 13 (B) (a) (iii), the following is substituted:**

**iii) For the Post Code nos. 11 and 12 (For Women candidates):** In the case of a widow, a divorced woman or a woman judicially separated from her husband, and who is not remarried,

- a) If she is a SC or ST, must have attained the age of 18 years and must not have attained the age of 40 years on 1<sup>st</sup> July, 2016. However, the Government of Telangana vide G.O.Ms.No.26, Home (Legal) Department, dated. 02-03-2016 has raised the maximum age limit by (4) years. This relaxation is in addition to the upper age limit as mentioned above.
- b) In the case of all other categories i.e., other than SC & ST, the candidate must have attained the age of 18 years and must not have attained the age of 35 years as on 1<sup>st</sup> July, 2016. However, the Government of Telangana vide G.O.Ms.No.26, Home (Legal) Department, dated. 02-03-2016 has raised the maximum age limit by (4) years. This relaxation is in addition to the upper age limit as mentioned above.

The last date for receipt of online applications is extended from 03-03-2016 to **10-03-2016 Midnight.**
